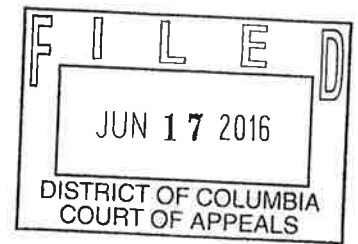

ORDER

On consideration of the notices of appeal wherein appellants seek review of an order denying a special motion to dismiss; and it appearing despite appellants' assertion to the contrary, that *Doe No. 1 v. Burke*, 91 A.3d 1031, 1037 n.6 (D.C. 2014), governs these appeals, that case did not address whether an order denying a special motion to dismiss under the anti-SLAPP Act is immediately appealable; and it further appearing that there is pending before this court appeal no. 14-CV-101, *Competitive Enterprise Institute, et al., v. Michael E. Mann*, and appeal no. 14-CV-126, *National Review v. Michael E. Mann*, which are appeals from orders denying special motions to dismiss pursuant to D.C. Code § 16-5502 (2012 Repl.) of the anti-SLAPP Act; it is

ORDERED, *sua sponte*, that appeal nos. 16-CV-458, 16-CV-459, 16-CV-500 and 16-CV-558 are hereby consolidated for all purposes herein. It is

Nos. 16-CV-458, 16-CV-459, 16-CV-500 and 16-CV-558

FURTHER ORDERED that these consolidated appeals are hereby held in abeyance pending a decision in appeal nos. 14-CV-101 and 14-CV-126.
