DEFENDANT JONATHAN DARNEL’S NOTICE OF APPEAL OF
ORDER DENYING HIS SPECIAL MOTION TO DISMISS

PLEASE TAKE NOTICE that Defendant Jonathan Darnel hereby appeals to the District of Columbia Court of Appeals from the Order of the Civil Division of this Court, entered on April 29, 2016 (the “Order”), denying his Special Motion to Dismiss Plaintiff’s Complaint that was filed under the authority of section 16-5502 of the District of Columbia code.

The Order was not set forth on a separate document. The docket entry is attached.

The Order appealed from is not final, but an immediate appeal nonetheless may be taken under the collateral-order doctrine. *See Doe No. 1 v. Burke*, 91 A.3d 1031 (D.C. 2014).

No other notices of appeal have yet been filed in this case.

The status of this Civil II case is “Paid,” and undersigned counsel was not appointed in the trial court.

The proceeding at which the Order was issued was held on April 29, 2016, beginning at approximately 11:50 am, in Courtroom 221. No court reporter was present, but the proceeding audio recorded.
